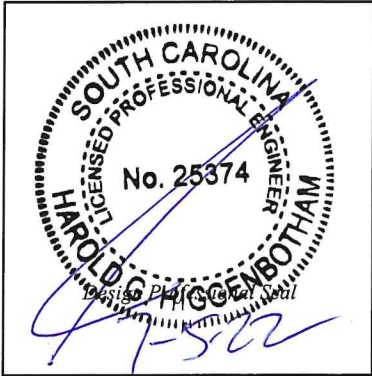
Interim reports shall be submitted to the Code Official and the Registered Design Professional in Responsible Charge.
